#### Instructions for Ph.D. Course Work (2024)

- As per the Regulation 10 (i) of the Maharashtra National Law University, Nagpur Ph.D. (Doctor of Philosophy) Regulations 2017, the Ph.D. course work shall be of **22 credits** in total divided in Seven (07) Courses including the course titled "Research and Publication Ethics (RPE)" as per the University Grants Commission 543<sup>rd</sup> Meeting Resolution held on August 9<sup>th</sup>, 2019 (Vide Letter No. F. I.-1/2018 (Journal CARE) dated December, 2019). However, for external Research Scholars, only following courses will be offered:

- No Registration fee for attending the Ph.D. course work;
- The classes will be conducted online using Cisco WebEx Portal;
- The total duration of the course work shall be split into three clusters, spread over the entire Semester period;
- Convenor, Doctoral Council and Coordinators shall coordinate the Ph.D. course work including class schedule and liaisoning with subject experts;
- The candidates who are regular in attendance and does not take part in course work Examination will get the Participation Certificate from the University;
- The candidates who are regular in attendance, appeared and passed the course work Examination will get the Course Work Completion Certificate from the University; and
- The University reserves the right to expel any candidate at any point of time during the period of course work if the candidate's involvement is not satisfactory.
