

SHRI RAM JETHMALANI MERIT-CUM-NEED
SCHOLARSHIP REGULATIONS-2021

These Regulations may be called as Shri Ram Jethmalani Scholarship Regulations under which Scholarship may be provided to the eligible Students of V, IV, III and II Year of Five-Year Undergraduate Courses.

1. Definitions

- 1.1 '**Scholarship**' means financial assistance provided to registered student/s of the Undergraduate Courses.
- 1.2 '**Scholarship Amount**' means the amount to be recommended by the Scholarship Committee after taking into consideration the Interest earned from the donation.
- 1.3 '**Scholarship Committee**' means a Committee constituted by the Vice-Chancellor for the purpose of determining and disbursement of the Scholarship under these Regulations.
- 1.4 '**Interest**' means the amount of Interest accrued on the donation amount up to the end of the respective Financial Year.
- 1.5 '**Income**' means annual income of the parents as per the Return of Income filed with the Income Tax Department.
- 1.6 '**Disciplinary Action**' means any action recommended / initiated by the Disciplinary Committee duly constituted by the Vice-Chancellor against a registered student/s.

2. Eligibility

- 2.1 Scholarship shall be awarded to the students based on the criteria of **merit and needs**. The eligible students shall be shortlisted based on a point-based system, wherein the weightage given to merit based on the CGPA and in accordance to other parameters.
- 2.2 Students of second year onwards can apply for the Scholarship.
- 2.3 Applicant must have at least 75% or above attendance in pervious semester/s.
- 2.4 Applicant must be on roll as a student of the University.
- 2.5 There should not be any disciplinary action / enquiry record of the applicant.
- 2.6 There should not be any backlog and failure in any course.
- 2.7 There should not be any bar by the order of the University authority in previous academic year.
- 2.8 A student with at least 6.0 CGPA in previous year will be considered for Merit Based Scholarship.
- 2.9 As student will be considered for Need Based Scholarship only when the parents' income should not be more than Rs.8,00,000/- per annum.

3. General Conditions

- 3.1 No scholarship can be claimed as a matter of right.
- 3.2 Every year in the month of July the application for Scholarship will be released through a proper Notification and the disbursement of the Scholarship amount will be made in the month of August.

- 3.3 Students shall apply through proper format and attach the prescribed documents with application form.
- 3.4 Students claiming Scholarship under Need category are required to submit the Scholarship Form along with Return of Income of parent/s for the previous financial year or Income Certificate issued by the Revenue Department of the concerned State Government as an evidence of parental income.
- 3.5 Students are also required to submit a declaration stating that 'he/she is not availing any scholarship' along with the application.
- 3.6 In the event a student fails to disclose the necessary details or submits incomplete application form or incorrectly states or fails to disclose any of the particulars as required or submits fake or forged information or forged supportive document, the Scholarship Committee reserves the right to take action as it may deem fit.
- 3.7 The amount on scholarship to be awarded shall be decided by the Scholarship Committee depending on the number of eligible applicants and availability of the funds in the Scholarship Corpus. The Scholarship may extend upto 50 percent of the tuition fee.
- 3.8 If a student who has been awarded Scholarship under Merit Category relinquishes the Scholarship amount then, such student shall be treated as a Scholarship awardee and a Certificate shall be issued accordingly.

4. Discretionary Powers of the Vice Chancellor

- 4.1 The Vice-Chancellor shall have the discretionary power to award a full Fee remission, or any portion thereof, to any student who the Vice-Chancellor deems fit, upon a special written request by the student and recommendation in this regard by the Scholarship Committee.
- 4.2 All decisions of the Scholarship Committee shall be opened to appeal to the Vice Chancellor of the University within one week from the date of notification of the result. The decision of the Vice-Chancellor shall be final and binding.
